## PROPOSED AMENDMENTS TO THE MEMORANDUM AND ARTICLES OF ASSOCIATION

The board of directors of the Company (the "Board") proposes to make certain amendments to the existing Memorandum and Articles of Association to (i) conform to the Core Standards; (ii) allow general meetings to be held as electronic meetings or hybrid meetings in order to modernise the conduct of general meetings and provide flexibility to the Company in this respect; (iii) bring the Memorandum and Articles of Association in line with amendments made to the Listing Rules and the applicable law and procedures in the Cayman Islands; and (iv) to incorporate certain housekeeping changes. For the purposes of the aforesaid proposed amendments, the Board proposes to adopt the second amended and restated Memorandum and Articles of Association in substitution for, and to the exclusion of, the existing Memorandum and Articles of Association.

The proposed amendments to the Memorandum and Articles of Association shall be subject to the passing of a special resolution by the shareholders of the Company at the forthcoming annual general meeting of the Company to be held on 25 May 2023 (the "AGM"), and the second amended and restated Memorandum and Articles of Association shall become effective upon the passing of such special resolution at the AGM. A circular containing, among others, details of the proposed amendments to the Memorandum and Articles of Association and a notice convening the AGM will be despatched to the Company's shareholders as soon as practicable.
